PETITION FOR DETERMINATION OF
THE WATER LEVEL OF BLACK LAKE

Now comes the County of Cheboygan, by and through Nicholas V. Hile, Cheboygan County Prosecuting Attorney, and for its Petition shows unto this honorable Court as follows:

1. This Petition is filed pursuant to Act 194 of the Public Acts of 1939, as amended, being Michigan Statutes Annotated Section 11.221 etseq.
2. That a regular meeting of the Board of Supervisors for the County of Cheboygan, held in the Cheboygan County Court House, on ~~28th~~ day of ~~August~~, 1963, a resolution was adopted, a copy of which is attached hereto and incorporated herein by reference, directing the Cheboygan County Prosecutor to institute proceedings for the determination of the water level of Black Lake.
3. That Black Lake is located partially in the County of Cheboygan and partially in the County of Presque Isle, and your Petitioner is informed and believes that the Board of Supervisors for the County of Presque Isle have likewise adopted a resolution directing the Presque Isle County Prosecuting Attorney to join in these proceedings for the determination of the water level of Black Lake.
4. That that portion of Black Lake located in Cheboygan County is situated in the Townships of Grant and Waverly.
5. That the reason for the determination of the water level of Black Lake is that the Alverno dam, located on Black River, and which is capable of controlling the water level of Black Lake, will be transferred to the County of Cheboygan and thereafter operated and maintained by the County of Cheboygan, and that certain dredging operations are anticipated between the headwaters of Black River, located at Black Lake, and said Alverno dam and that for the purpose of these dredging operations together with the operation

and maintenance of the so-called Alverno dam, it is necessary that the proper level of Black Lake be maintained at a level to be determined by this Court.

WHEREFORE, THE Petitioner prays that this Court picks a date for a hearing for the determination of the water level of Black Lake, and thereupon determine by order of this Court the legal water level of Black Lake.

The Petition of the County of Cheboygan joined by the County of Presque Isle, pursuant to Act #146, Public Acts of 1961, as amended, praying for the determination of the legal level of Black Lake, located in Cheboygan County and Presque Isle County, having been brought on for hearing after due notice of hearing and publication as require by said statute; and Nicholas V. Hile, Prosecuting Attorney for the County of Cheboygan, and Elmer L. Radka, Prosecuting Attorney for the County of Presque Isle, appearing representing their respective Counties and the Court having heard the testimony and examined the evidence received therein, and having been fully advised in the premises:


IT IS HEREBY ORDERED and adjudged that the legal level of the waters of Black Lake, shall be and is hereby determined to be, 612.2 feet above mean sea level datum, during the period beginning the 15th of May each year through the 31st day of October each year, and shall hereafter be known as the summer level.

It is further ordered and adjudged that the legal level of the waters of Black Lake, shall be and is hereby determined to be, 610.5 feet above mean sea level datum, during the period beginning December 1st, through April 15th, and shall hereafter be known as the winter level.

It is further ordered and adjudged during the period beginning April 15th and ending May 15th, of each year the water shall be raised from the winter level to the summer level, and during the month of November, the water shall

be lowered from the summer level to the winter level.

Said Black Lake, is located in Sections 3, 10, 11, and 12, T35N, R1E, Township of Waverly, Cheboygan County Michigan, and Sections 13, 14, 15, 16, 21, 23, 24, 27, 28, and 34, Township of Grant, Cheboygan County Michigan and Sections 30, 31, and 32, T35N, R2E, Township of Bearinger, Presque Isle County Michigan, and Sections 5, 7, 8, T35N, R2E, Township North Allis Presque Isle County Michigan.


